



HONDA AUSSIE GROM MSX125 LIMITED WARRANTY

In order to take advantage of the HONDA MSX125 limited warranty, you must have maintenance performed according to the schedule (contained in the relevant owner's manual supplied with this product), by a licensed motorcycle dealer. You are free to have your HONDA MSX125 serviced by any suitably qualified mechanic and this will not affect your statutory warranties, however, failure by the owner to have the recommended servicing carried out by a licensed dealer means that you cannot take advantage of this limited warranty.

In order to ensure your safety, we strongly recommend that you only use a licensed dealer for servicing. Only licensed dealers have access to all of the special tools and training required to maintain your MSX125 in peak operating condition.

Ballina Motorcycles warrants each new MSX125 Motorcycle to be free from defects in material and workmanship under normal domestic* use and service for the period specified below, conditional to the limitations and exclusions printed on this page. This warranty applies only to new HONDA MSX125's distributed in Australia by Ballina Motorcycles Pty Ltd.

The owner must keep a record of all services and maintenance by way of licensed dealer's receipts, as proof of service history may be required.

The proof of purchase documentation must accompany the motorcycle when warrantable repairs are requested.

Ballina Motorcycles will repair or replace any part which proves defective within the limits of this warranty at no charge to the owner for replacement parts and labour.

Consumables such as, but not limited to, oils, coolants, filters and spark plugs shall be the responsibility of the owner. All defective parts replaced under this warranty become the property of Ballina Motorcycles Pty Ltd. Transportation cost for the product either to or from Ballina Motorcycles is the responsibility of the owner.

This warranty will not apply to:

- Any part that has been subject to misuse, negligence, accidental damage, improper or inadequate maintenance, or improper storage.
- Repair rendered necessary or arising from the use of other than genuine HONDA parts.
- Normal maintenance items including but not limited to adjustment and cleaning of the fuel injection components, fuel strainer, oil & air filter, cables, brake components, intake valves, exhaust valves, clutches and serviceable bearings.
- Normal replacements of service items including but not limited to spark plugs, air & oil filters, tyres, brake pads, lightbulbs, fuses, clutch components and serviceable bearings.
- Deterioration of any item due to normal use, fair wear and exposure unless due to a defect in material or workmanship.
- Any work or adjustment performed by persons other than a licensed dealer or damage resulting therefrom.
- Any damage that results from operating methods other than those indicated in the owner's manual, or use beyond the limitations or specifications as published in the owner's manual.
- Using the motorcycle for racing or competition.
- HONDA MSX125's modified from original HONDA specifications or fitted with a sports kit will void warranty. (Modifications include but are not limited to, big bore kit's, modified camshafts, sprocket size, gear ratios, electrical loads, carburation, and intake and exhaust system changes.)

LIMITATIONS AND EXCLUSIONS

Tyres are warranted against defects in material and workmanship on a pro rata basis computed from the remaining original tread depth and according to the manufacturer's adjustment price schedule currently in use at the time of adjustment.

Motorcycle Batteries will be replaced on a pro rata basis computed from the remaining warranted period of the HONDA motorcycle to which this warranty pertains.

Batteries supplied on HONDA MSX125's as original equipment are warranted for a period of 12 months domestic use and 6 months commercial use.

* Domestic Use: Personal, residential or household use only.

Commercial Use: All uses other than domestic use, including use for income producing or rental purposes.

The benefits conferred by this warranty are in addition to all other rights and remedies in respect of the product (or service) which the consumer has under Australian Consumer Law and any other law in relation to the goods and services to which this warranty relates. Where permitted the liability of Ballina Motorcycles Pty Ltd shall be limited at its option, to the repair or the replacement of the goods. Our goods come with guarantees that cannot be excluded under the Australian Consumer Law. You are entitled to a replacement or refund for a major failure and compensation for any other foreseeable loss or damage. You are also entitled to have the goods repaired or replaced if the goods fail to be of acceptable quality and the failure does not amount to a major failure.
